In Training modules also there is no mention of all training will involve both BIPV and RIPV 50-50% or otherwise. Please clarify.	The trainings are not intended to be 50% BIPV and 50% RIPV or any other distribution. It is upon the consultant's judgment, experience and most of all – learnings from the initial research to determine the share of the two topics. The consultant will then suggest a needs-based training schedule accordingly.
	General	The previous study done by CSTEP and GIZ concludes lesser potential of RIPV in India with limited implementation scope. Therefore, We suggest if this TOR should only focus on BIPV training.	The subject matter of this tender remains unchanged.
4	The consultant shall review, update and develop two comprehensive training modules for BIPV and RIPV catering to students	Is the consultant required to develop two modules each for each category or a total of two training modules? Does each module have to have different sections for different stakeholders or do different modules need to be created for different audiences?	The consultant is required to propose a module design addressing the training needs of the target group. The final definition of the target group and its training needs is expected to emerge during WPI. A tentative module design is provided in the ToR.
8	Deliverables points 2.2.1.3 to 2.2.1.7.	As per our understanding, the consultant needs to deliver the trainings to both students and professionals in the phase 1 with a certain number of trainings. Further, in consultations with GIZ, they need to re-work the training modules, and finally deliver the final trainings again with the professionals and students. Hence, there will be two training phases- preliminary and final, the latter dependent on GIZ's inputs and learnings from preliminary sessions. Is that correct?	Partially correct: the second phase-trainings will be revised upon the feedback generated from the documented reflection and feedback on training forms. GIZ's role is the approval of the revised training material only. Yes, the audience will be different in every training.
